CERTIFICATE OF WATER RIGHT

This Is to Certify, that E. H. CLAYTON

of McKinley Route, Coquille ,S of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of East Fork Cocuille River

a tributary of Coquille River Irrigation

for the purpose of

under Permit No. 13660

of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 6, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.35 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream The point of diversion is located in the Lot 6 (SE2 SE3), Lot 5 (NK3 SE2), Lot 5 (SK3 SE2), Section 30, Township 28 South, Range 11 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 25 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

> 0.2 acre in the NE SE;, 15.6 acres in Lot 5 (NE SE;)(SE; SE;), 12.0 acres in Lot 6 (SE; SE;), Section 30, T. 28 S., R. 11 N., N. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Commencing at quarter section corner between Sections 29 and 30 T 28 S 2 11 W. of the Willemette Meridian in Coos Co. Ore. thence West 7.16 chains to a stake marked C.S. thence South 13.79 chains to a stake marked C.S. thence south 43 degrees West 20.21 chains to a mayle tree cor tree thence up the right bank of the East fork of the Coquille river to the section line between sections 29 and 30 thence north on section line between 29 and 30 to place of beginning (this property was bought in two pieces)

Beginning at a point 7.19 chains west of the quarter section corner between sections 29 and 30 T 28 south of Range 11 W. of the Willamette Meridian at a stake marked C.S. thence south 13.77 chains to a stake werked C.S. thence south 43 degrees west 20.21 chains to a maple tree marked cor. tree, thence down the right bank of the East fork of the Coquille river to a stake marked Cor S. thence north 45 degrees East 24.84 chains to a stake marked 1 2 C.S. thence East 13.02 chains the place of beginning.
