CERTIFICATE OF WATER RIGHT

This Is to Certify, That Clyde Minard, RAY L. ELLIS, ARLIN BARKLOW, FRANK ROBLISON

of Coquille , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of An unnamed Creek a tributary of Ruid Creek and on to Compine type Creek for the number of

a tributary of Budd Creek and on to Cunninghum Creek

for the purpose of

under Permit No. 13986 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 23, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.03 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NET NWZ, Section 36, Township 27 South, Range 13 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

W. corner of the SE of the NW; of said Section 36; and running thence S. 58 06 E. along the line of the foot of the hill for a distance of 50 feet; thence S. 49 30 E. along the foothill line for a distance of 267.29 feet; more or less; to a point on the East boundary of the said SE; of the NW; of Section 36; thence Northerly along the said East boundary of the NW; of Section 36 for a distance of 533 feet; thence N/ 86 04 W. for a distance of 76 feet; thence S. 16 21 W. for a distance of 170.50 feet; thence S. 45 39 W. for a Distance of 322.8 feet to the point of beginning and containing 2.40 acres, wore or less, and being a portion of the SE of the NW; and of the NES of the NW; of section 36, Township 27 South Range 13 West of the Willemette Seridian.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
