CERTIFICATE OF WATER RIGHT

This Is to Certify, That LEO E. PAULUS

of Route 1, Box 48B, North Bend, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Unnamed Creek

a tributary of Coos Bay for the purpose of Domestic

under Permit No. 14118 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 12, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the S $\frac{1}{4}$ S $\frac{1}{4}$, Section 1, Township 25 South, Range 13 West, T. 25 S., R. 13 W., N. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Lot 5 (NE $\frac{1}{4}$ NW $\frac{1}{4}$),
Section 12,
T. 25 S., R. 13 W., N. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Beginning at a point on the South boundary of Section 1, Township 25 South, Range 13 West of the Willamette Meridian, to a distance of 689.12 feet West of the iron pipe at the quarter section corner on the South boundary of said Section 1, and running thence West along the said South boundary of Section 1 for a distance of 50 feet, thence North 33°47' West for a distance of 360.95 feet; thence North 11°21' West for a distance of 305.96 feet; thence West for a distance of 1086.88 feet; thence South 9°16' East for a distance of 400.0 feet; thence South 14°41' East for a distance of 212.14 feet to a point on the said South boundary of Section 1 a distance of 670.61 feet East from the iron pipe at the South West corner of the said Section 1; thence East along the said South boundary of Section 1 for a distance of 345.15 feet; thence South for a distance of 341.0 feet to a point on the boundary of the county road; thence following along the said Northerly boundary of the County road as follows: South 68°43' East for a distance of 50.0 feet; thence South 47°28½' East for a distance of 50.0 feet; thence South 75°28' East for a distance of 50.0 feet; thence North 69°06' East for a distance of 50°0 feet; thence North 49°18' East for a distance

of 350.0 feet; thence North $52^{\circ}30'$ East for a distance of $24^{\circ}13'$ feet; thence North $59^{\circ}35'$ East for a distance of 50.0 feet; thence North $78^{\circ}01\frac{1}{2}'$ East for a distance of 50.0 feet; thence South $83^{\circ}32'$ East for a distance of 50.0 feet; thence South $65^{\circ}56'$ East for a distance of 45.43 feet; thence South $48^{\circ}21'$ East for a distance of 50.0 feet; thence South $29^{\circ}54\frac{1}{2}'$ East for a distance of 50.0 feet; thence South $9^{\circ}37\frac{1}{2}'$ East for a distance of 55.0 feet; thence leaving the boundary of the County road and running East for a distance of 272.57 feet; thence North $11^{\circ}56'$ West for a distance of 269.89 feet to the point of beginning; containing 15.56 acres in the South half of the South West quarter of Section 11 and 5.56 acres in lots 5 and 6 of Section 12, both in township 25 South, Range 13 West of the Willamette Meridian making a total of 21.12 acres.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
