**CERTIFICATE OF WATER RIGHT**

**This Is to Certify,** That KATHLEEN O'BRIEN

of Pistol River, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Unnamed Creek

a tributary of Pacific Ocean for the purpose of domestic use and to operate ran, being 4.5 g.p.m. for ran and 1g.p.m. for domestic. under Permit No. 14286 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 9, 1940

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 5.5 gallons per minute,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 3, Section 18, Township 38 South, Range 14 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Lot 3 (NW $\frac{1}{4}$  SE $\frac{1}{4}$ ),  
Section 18,  
T. 38 S., R. 14 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

That certain tract of land consisting of 38.6 acres, more or less, (of which 14.0 acres, more or less, is beach land lying outside the Government meander line and 24.6 acres, more or less, is upland within the meander line) situate in the NE $\frac{1}{4}$ SE $\frac{1}{4}$  and Lot 3 in Sec 18 of Twp. 38 S., Range 14 W.M., in Curry County, Oregon, and more particularly described as follows, to-wit:

Commencing at an iron pipe driven on the proximate West boundary of the Oregon Coast Highway at a point 1631.9 feet North and 1147.7 feet West of the southeast corner of said Sec. 18;

Thence S88°16 feet W, 1950 feet, more or less, to the line of ordinary high water mark of the Pacific ocean; Thence northerly along the line of ordinary high water mark of the Pacific ocean to an intersection with the North boundary line of said Lot 3; Thence N88°16ftE, 1525 feet, more or less, to an iron pipe driven in the proximate West boundary line of the Oregon Coast Highway; Thence southeasterly, following the West boundary line of said highway, to the point of beginning.

And also a perpetual right and easement, appurtenant to and running with the land

hereinabove described, to install and maintain a hydraulic ram, or power driven pump, together with the intake and outlet pipe or conduits for the same, and diversion dam, if needed, over, in and upon a strip of land 20 feet in width, being 10 feet in width upon each side of a center line particularly described as follows: commencing at a point 1558.00 feet North and 2000.0 feet West of the Southeast corner of Section 18 aforesaid; thence due West 125.0 feet; Thence N44°E, 65.0 feet more or less, to the South boundary line of the tract of land hereinabove described and hereby granted and conveyed.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
