CERTIFICATE OF WATER RIGHT

This Is to Certify, That s. o. NEHHOUSE

Wedderburn Gregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Unnamed Spring

a tributary of Rogue River

for the purpose of

Irrigation under Permit No. 14854 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 3, 1941

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.0125 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 6 (RE SFI), Section 25, Township 36 South, Range 15 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightleth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $4\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season from April 2 to October 31 of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

> 0.5 acre in Lot 6. Section 25, T. 36 S., R. 15 H., W. M.

Land on which water is to be used is a part of the property wore explicitly described by appropriator as follows:

Beginning at a point on the North boundary of the County Road, 925.0 feet South and 116.8 feet west of the 1 Section Corner on the East side of said Section 25.

Thence North 00 13' East 108.8 feet to an iron pipe.

Thence North 89° 47' West 271.5 feet to an iron pipe.
Thence North 68° 52' West 153.1 feet to an iron pipe.
Thence South 30° 53' Rest 35.1 feet to an iron pipe, on the East line of the

tract now owned by School District #2 of Curry County, Oregon.

Thence South 2º 20' East 189.8 feet to an iron pipe driven on the North boundary of the County Road.

Thence, following the Northerly boundary of the County Road, Rorth 64° 52' East 60.0 feet.

Thence North 83° 37' East 200.0 foot to an iron pipe. Thence North 87° 33' East 171.0 feet to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
