CERTIFICATE OF WATER RIGHT

This Is to Certify, That HENRY J. ANDERSON

of Route 2, Box 207, Woodburn , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Butte Creek

a tributary of Pudding River Irrigation

for the purpose of

under Permit No. 15213 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from 15, 1942

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.08 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEt. NET as projected on D.L.C. No. 63, Section 36, Township 5 South, Range 1 West, N. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 25 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.4 acres in the HF. NE as projected on Wm. T. Easthem D.L.C. 63, 4.0 acres in the SE NE as projected on Wm. F. Easthem D.L.C. 63, Section 36, T. 5 S., R. 1 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Beginning at the Southeast corner of the North one-half (2) of the William F. Eastham and wife Donation Land Claim #63 Township 5 South Range 1 West W. M. Marion County, Oregon; and running thence North along the East line of said claim 15.94 chains; then South 75° 30° West 11.06 chains to the center of the County road; thence South 29° 40° East 16.02 chains to the South line of the North half of said claim; thence East along said line 3 chains to the place of beginning, containing 10 acres of land, more or less and being a part of the William F. Eastham Donation Land Claim #63 Township 5 South Range 1 West Willamette Meridian Marion County, Oregon.

Also, Beginning at a point on the North line of the South Half of the W. F. Eastham's Donation Land Claim, as described in a deed given by G. E. Pottratz and Emma Pottratz, his wife to Henry Berning, and said deed recorded in the Marion County, Oregon, records in Vol. 95 Page 40 on the 7th day of Jan. 1907 and said point of

beginning being 2.86 chains West from the North easy corner of said described tract, thence running East on said North line 2.86 chains to the said North East corner; thence South on the East line of said tract 4.64, chains into the Public Road as now is used for road; thence in a Northwesterly direction following said Public Road 5.60 chains to the point of beginning containing .66 of an acre of land more or less, and being all the land lying east of the Public Road as above described.
