CERTIFICATE OF WATER RIGHT

This Is to Certify, That J. E. CUPP AND HAUDE CUPP, 2227 Agate St., Eugene, Oregon, DR. IRVIE R. FOX AND EDYL C. FOX, 1955 University St., Eugene, Oregon, FRANK FIELDS AND // DOROTHY FIELDS, Mapleton, Oregon Appleton, Oregon of a right to the use of the waters of

Snell Creek a tributary of Siuslaw River for the purpose of Domestic and Irrigation, being 0.02 c.f.s. for domestic and 0.02 c.f.s. for irrigation. under Permit No. 15282 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 23, 1942

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.04 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 1 (SK: SK:), Section 35, Township 17 South, Range 10 West, K. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year, and shall be limited still further to a total diversion of not to exceed 0.02 c.f.s. for irrigation,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.5 acre in Lot 1 (SW SW),
domestic use in Lot 1 (SW SW),
Section 35,
T. 17 S., A. 10 W., W. M.
1.5 acres in Lot 4 (NW NW).
domestic use in Lot 4 (NW NW),
Section 2,
T. 18 S., R. 10 W., W. M.

Land on which water is to be used is a pert of the property more explicitly described by appropriator as follows:

Beginning at a point which point is 291 feet east and south 72° east 186 feet from the meander corner located on the section line between sections 34 and 35, in township 17 South Range 10 West of Fillamette Meridian, 38.17 chains south of the quarter section corner between said sections, and run thence south 74° 30' East 187 feet, thence South 36° 30' east 151 feet, thence North 33° 30' East 632 feet, thence north 60° west 650 feet more or less to a point North 5° east from the place of beginning, and thence south 5° west 680 feet, more or less, to the place of beginning, in Lane County, Oregon.

Except a strip of land 40 feet wide running in an easterly and westerly direction previously deeded to Lane County, State of Oregon, for highway purposes.
