**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** FRED SVINTH

of Box 66, Prospect, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Mill Creek, North Fork Rogue

a tributary of Rogue River for the purpose of domestic, including the irrigation of a lawn not exceeding  $\frac{1}{2}$  acre in area, and swimming pool, being 4 S.P. of the State Engineer, and that said right to the use of said waters under Permit No. 15370 has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 9, 1942

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 10 gallons per minute,

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NW $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 32, Township 32 South, Range 3 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Domestic use for four families including the irrigation of a lawn not exceeding  $\frac{1}{2}$  acre in area and use for a swimming pool in the NE $\frac{1}{4}$  NW $\frac{1}{4}$ ,  
Section 32,

T. 32 S., R. 3 E., W. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Starting at the northwest corner of the southwest quarter of the northeast quarter of the northwest quarter; thence east 407 feet along the division line between the northwest quarter and the southwest quarter of the northeast quarter of the northwest quarter to hub stake; thence south 37° east 155 feet to a stake in the right of way of the Crater Lake Highway approximately at right angles to the center line of said highway; thence along said highway right of way in a southwesterly direction 570 feet to a stake in the division line of lands between Rogue River Timber Company and The California Oregon Power Company, being the west line of the northeast quarter of the northwest quarter; thence north along said west line 426 $\frac{1}{2}$  feet to place of beginning, containing 3- $\frac{2}{10}$  acres more or less; excepting therefrom a strip of land 16 feet in width for a right of way from Crater Lake Highway to the gate of the California Oregon Power Company on the road leading to that Company's dam on the North Fork of Rogue River.

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.*
