CERTIFICATE OF WATER RIGHT

This Is to Certify, that the estate of ames thomas hillman and elizabeth hillman

of 1258 West 21st St., San Pedro State of California , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rogue River

a tributary of Pacific Ocean

for the purpose of

Irrigation

under Permit No. 15558 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 29, 1943

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.13 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NET SET as projected on D.L.C. No. 37, Section 14, Township 36 South, Range 6 West, W. K.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 42 acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.0 acres in the JET NWT as projected on James P. Tuffs D.L.C. No. 37, 5.0 acres in the NET SET as projected on James P. Tuffs D.L.C. No. 37, Section 14, T. 36 S., R. 6 K., W. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Beginning at a point from which the Northwest corner of Donation Land Claim No. 37, Section 14, Township 36 South, Range 6 West of the Killanette Meridian, Oregon, bears North 50° West, 1255 feet distant, and which point is in the center of ditch; running thence along the center of said ditch South 72° 55! East 330.47 feet; thence due South to the center of the County Road, 1378.4 feet; thence along the center of said County Road North 74° 30' West, 329.87 feet; thence North 1388.1 feet to the center of aforesaid ditch and place of beginning, containing 10.16 acres, more or less.
