## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

Louis and Eva Hendricks

of

Aumsville

, State of Oregon

, has a right to the use of

for the purpose of Domestic including irrigation of a garden not exceeding 0.5 acre, and stock;

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Marion County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 14, at page 357; that the priority of the right thereby confirmed dates from 1850;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 for domestic including irrigation of a garden not exceeding 0.5 acre, and stock from Spring in NE4 NE4, Sec. 4, T. 9 S., R. 1 W., W.M., and the amount for stock purposes from Mill Creek and unnamed stream shall be determined in accordance with the provisions of said decree.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

For domestic use including irrigation of garden not exceeding 0.5 acre, and stock use from Spring in  $NE_4^1$ ,  $NE_2^1$ , Sec. 4, T. 9 S., R. 1 W., W.M., and for stock use from Mill Creek, within the following described tract:

Beginning at the most easterly corner of the Henry Foster and wife D. L. C. No. 45 in T. 9 S., R 1 W. of the Willamette Meridian, Marion County, Oregon; thence west 14.14 chains to the remotest corner in the northline of the Foster claim; thence north 8 chains to the most northerly NE corner of the claim No. 45; thence west 27.89 canins along the north line of the Foster claim No. 45 to a 20-acre tract deeded off of the west side of the east half of the Henry Foster and wife claim; thence south 0° 15' E. 14.33 chains along the east line of said 20 acre tract; thence east 21.99 chains; thence S. 0° 45' East 1.63 chains; thence north 89° 45' east 20 chains to the east line of Claim No. 45; thence north 0° 45' W. 7.87 chains to the place of beginning, containing 52 acres of land.

For stock use from unnamed stream within the following described tract:

Beginning at a point 8.00 chains N. 0° 30' W. and 21.51 chains west from the most southerly SE corner of the Donation Land Claim of Gabriel Brown and wife in T. 9 S., R. 1 W., W. M., Marion County, Oregon; thence N. 0° 30' West 46.50 chains parallel with the east line of said claim; thence west 10.92½ chains; thence S. 0° 30' E. 46.50 chains parallel with the east line of said claim; thence East 10.96½ chains to the place of beginning, and containing 51 acres of land, more or less. SAVE AND EXCEPT ten (10) acres of land off the south end of above described tract which was sold to Joseph L. Schulte, leaving in above tract fortyone (41) acres of land, more or less.

And said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
