CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That S. W. HOLMES

of Ostrander State of Washington has a right to the use of the waters of North Powder River, a tributary of Powder River, and waste waters from North Powder Milling Company Mill Race

for the purpose of the irrigation of 367 acres of land and domestic and stock use

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Union County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume 5 at page 252 ; that the priority of the right hereby confirmed dates from the year 1887 for the irrigation of 259 1/2 acres, and 1888 for 107 1/2 acres;

that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed a rate of flow of 9.20 sec. ft. from March 1st to July 1st and 4.60 sec. ft. from July 1st to October 1st of each year; the total quantity diverted during each irrigation season not to exceed 918 acre feet.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows: 21 1/2 acres in NE 1/4 of NE 1/2; 35 ac. in NW 1/2 of NE 1/2; 30 acres in SE 1/4 of NW 1/2; Section Twenty-three (23), 37 acres in NW 1/4 of SW 1/2; Section Twenty-four (24), 23 1/2 acres in NE 1/4 of NE 1/2; 38 1/2 acres in NW 1/2 of NE 1/2; 34 acres in SE 1/2 of NE 1/2; 40 acres in NE 1/4 of NW 1/2 Section Twenty-six (26), Township Six (6) South, Range Thirty-nine (39) East of Willamette Meridian, in Baker County, Oregon. 32 acres in NW 1/2 of SE 1/4; 30 acres in SW 1/2 of SE 1/4 Section Fourteen (14) 32 acres in NE 1/4 of NW 1/2; 13 1/2 acres in SW 1/2 of NW 1/2; Section Twenty-three (23), Township Six (6) South, Range Thirty-nine (39) East of Willamette Meridian, in Union County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
