CERTIFICATE OF WATER RIGHT

This Is to Certify, That Wallace S. Wharton

of Route 2, Turner, , State of Oregon , has a right to the use of

the waters of Unnamed stream, tributary of Battle Creek and Unnamed spring in SW $\frac{1}{4}$ SE $\frac{1}{4}$, Sec. 36, T. 8 S., R. 3 W., W. M. for the purpose of Stock from Unnamed stream, tributary of Battle Creek, and irrigation, domestic and stock from Unnamed spring in SW $\frac{1}{4}$, SE $\frac{1}{4}$, Sec. 36, T. 8 W., R. 3 W., W.M. and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Marion County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 14 , at page 357 ; that the priority of the right thereby confirmed dates from 1871 for stock, and exclusive right for irrigation, domestic and stock;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second for stock from Unnamed stream and the exclusive right to Unnamed spring for irrigation, domestic and stock;

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

17.0 acres in NE $\frac{1}{4}$ SE $\frac{1}{4}$
 5.0 acres in SW $\frac{1}{4}$ SE $\frac{1}{4}$
 8.0 acres in SE $\frac{1}{4}$ SE $\frac{1}{4}$
 Section 36,
 T. 8 S., R. 3 W., W.M.
 being within the following
 described tract:

Beginning at the NE corner of Lot 4 in Sec. 36, in T. 8 S., R. 3 W., W. M., Marion County, Oregon; thence south along the East line of said section and of Section 1 in T. 9 S., R. 3 W., W. M., 40 chains; thence West 30 chains; thence North 28.50 chains; thence East 2.60 chains; thence North 11.63 chains to the SW corner of the David Delaney D. L. C. #42 in T. 8 S., R. 3 W.; thence East 28.50 chains to the place of beginning.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
