CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That ANDREW O. LUN

of North Powder State of Oregon 97867 has a right to the use of the waters of North Powder River, a tributary of Powder River

for the purpose of the irrigation of 240 1/2 acres of land, domestic and stock use, and ice-making from Oct. 15 to March 1st of each year;

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Union County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume B, at page 252 ; that the priority of the right hereby confirmed dates from the year 1884 for the irrigation of 37 acres; from 1870 for 203 1/2 acres; from 1886 for the use of 2.50 sec. ft. for ice-making;

that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purpose and shall not exceed a rate of flow for irrigation of 6.09 sec. ft. from March 1st to July 1st and 3.01 sec. ft. from July 1st to October 1st of each year; the total quantity diverted during each irrigation season not to exceed 60 1/2 acre feet.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows: 37 acres in SE 1/4 of NW 1/4; Section Twenty-seven (27), Township Six (6) South, Range Thirty-nine (39) East of Willamette Meridian, in Baker County, Oregon.

37 acres in NE 1/4 of SE 1/4; 17 acres in NW 1/4 of SE 1/4; 30 acres in SW 1/4 of SE 1/4; 13 acres in SE 1/4 of SW 1/4; Section Twenty-two (22), 35 1/2 acres in NE 1/4 of NW 1/4; 33 acres in NW 1/4 of NW 1/4; 37 acres in SW 1/4 of NW 1/4; Section Twenty-seven (27); 1 acre in NE 1/4 of NE 1/4 Section Twenty-eight (28), Township Six (6) South, Range Thirty-nine (39) East of Willamette Meridian, in Union County, Oregon.

Ice ponds consisting of about twenty acres in SE 1/4 of SW 1/4; Section Twenty-two (22), and NE 1/4 of NW 1/4, Section Twenty-seven (27), all in Township Six (6) South, Range Thirty-nine (39) East of Willamette Meridian, in Union County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
