## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

, has a right to the use of

the waters of Unnamed spring for irrigation, domestic and stock; Three unnamed springs and unnamed stream for stock;

for the purpose of

Irrigation, domestic and stock;

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Marion County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 14, at page 354; that the priority of the right thereby confirmed dates from 1866 for irrigation, domestic and stock, and for stock use with no diversions is subject to the provisions of Paragraph 165 of said decree;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall is subject to the provisions of Paragraph 165 of said decree;

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

M., in Marion County, Oregon, and the following-described parts of Lot 4 and the NW<sup>2</sup>/<sub>4</sub> SE<sup>4</sup>/<sub>5</sub>, Sec. 1: Beginning at a point on the north line of the donation lend claim of Alfred Fitzgerald in Tp. 9 S., R. 1 E., W. M., in Marion County, Oregon, said point being 7.00 chains west of the northeast corner of said claim; thence north 30.03 chains to a line running east and west through the center of Sec. 1 and being 49.34 chains east of the quarter section corner between Secs. 1 and 2; thence west to the center of the section; thence southerly along the center of the section to the north line of the Alfred Fitzgerald claim; thence east along the north line of said claim to the place of beginning, except the following which has been sold: Beginning at the quarter section corner between Secs. 1 and 2, Tp. 9 S., R. 1 E, W.
