## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That HERRY C. R. AKIN

of 1011: Porter Blug., Portland , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unmamed stream a tributary of Willamina River, tributary of Yamiill River for the purpose of irrigation

under Permit No. 10862 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 15, 1933;

that the amount of water to which such right is entitled and hereby confire for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.074 cubic foot per second measured at the point of diversion from the stream,

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SWANE4 & Lot 5 (NWASE4) Section 12, Township 5 South, Range 7 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.1 acres in SWANEA

4.8 acres in Lot 5 (NW SE 2) Section 12, T. 5 S., R. 7 W., W. H.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows: Beginning at a point that is South 32.25 charms and East 20.16 chains from the north quarter corner of Section 12, Township 5 South, Range 7 West, W. M., thence N 89° 30° W 17.36 chains, thence S 0° 30° W 6.00 chains, thence S 80° 02° west 13.28 chains, thence S 83° 00° W 9.60 chains, thence S 0° 30° W 22.50 chains, thence East 13.20 chains, thence North 1.50 chains, thence N 89° 17° E 8.33 chains, thence S 11° 30° E 7.91 chains, thence S 10° 19° W 2.27 chains, thence S 57° 58° E 1.73 chains, thence N 37° 21° E 6.13 chains, thence S 75° 58° E 1.32 chains, thence S 500 chains, thence N 28° E 7.99 chains, thence East 0.91 chains, thence North 1.60 chains, thence N 28° E 2.65 chains, thence North 6.81 chains, thence N 6° 15° E 6.50 chains, thence S 89° 30° E 5.50 chains, thence North 9.69 chains, thence N 89° 30° W 7.71 chains, to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
