the waters of Ditch Creek . . .

for the purpose of Irrigation and domestic

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Hood River County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 6, at page 200; that the priority of the right thereby confirmed dates from July, 1902

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed the quantity fixed in said decree.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

- 40 acres in S $\frac{1}{2}$ SE $\frac{1}{4}$
- 14.34 acres in N $\frac{1}{2}$ SE $\frac{1}{4}$

- 25 acres in S $\frac{1}{2}$ SE $\frac{1}{4}$
- 25 acres in N $\frac{1}{2}$ SE $\frac{1}{4}$

- 35 acres in N $\frac{1}{2}$

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
