## CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That MARY L. WHITE,  
of Willows, State of Oregon, has a right to the use of  
the waters of WILLOW CREEK and tributaries, tributary to the Columbia  
River, in Morrow County, Oregon,

for the purposes of irrigation and stock, (irrigation during the irrigation season)

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Morrow County, and the said decree entered of record at Salem, in the Order Record of the Board of Control of the State of Oregon, in Volume 1, at page 73; that the priority of the right hereby confirmed dates from 1885 for the irrigation of fifteen acres, from 1893 for the irrigation of fifty-five and one-half acres, from 1900 for the irrigation of twenty-nine acres, and from 1906 for the irrigation of four acres;

that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.25 cubic feet per second as of date 1885, 0.93 cubic feet per second as of date 1893, 0.49 cubic feet per second as of date 1900, and 0.06 cubic feet per second as of date 1906, not to exceed the rate of one-fortieth (1/40) of a second foot to each one thousand (1000) head of stock.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:

Five (5) acres in SE $\frac{1}{4}$  of NE $\frac{1}{4}$ ; five (5) acres in NE $\frac{1}{4}$  of SW $\frac{1}{4}$ ; nine (9) acres in NW $\frac{1}{4}$  of SW $\frac{1}{4}$ ; four (4) acres in SW $\frac{1}{4}$  of SW $\frac{1}{4}$ ; twenty-five (25) acres in SE $\frac{1}{4}$  of SW $\frac{1}{4}$ , Sec. 25; fifteen (15) acres in SE $\frac{1}{4}$  of SW $\frac{1}{4}$ ; Sec. 36; Tp. 4 N. R. 22 E., W. M.; six (6) acres in NW $\frac{1}{4}$  of NE $\frac{1}{4}$ ; fourteen (14) acres in SW $\frac{1}{4}$  of NE $\frac{1}{4}$ ; one and one-half (1 $\frac{1}{2}$ ) acres in NE $\frac{1}{4}$  of NW $\frac{1}{4}$ ; one (1) acre in NE $\frac{1}{4}$  of SE $\frac{1}{4}$ ; eighteen (18) acres in NW $\frac{1}{4}$  of SE $\frac{1}{4}$ ; Sec. 1, Tp. 3 N., R. 22 E., W. M., all in Gilliam County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
