## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That WALTER J. GEARIN

of Star Route, Newberg , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Willemette River a tributary of Columbia River for the purpose of Irrigation

under Permit No. 12557 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 18, 1937

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.38 cubic foot per second for irrigation,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NN SEA (Lot 7), Section 33, Township 3 South, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation seeson of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

10.0 acres in Lot 6 (NE 3 ST 1), 20.0 acres in Lot 7 (NT 1 SE 2), Section 32, T. 3 S., R. 2 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows: Beginning at the S.W. Corner of the D.L.C. of the heirs of Peter Belleque, Claim #71 in Township 4 South, Range 2 West of the Willamette Meridian in Marion County Oregon; thence North 15' West 20.50 chains; thence North 41.25 chains to the meander line of the Willamette River; thence North 84° and 15' East 26.78 chains; thence South 38.66 chains; thence East 1.52 chains; thence South 13.15 chains to the middle of the County road; thence South 89° 45' West in said road 1.52 chains; thence South 12.04 chains to the South line of said Donation Land Claim #71; thence South 88° 45' West 26.23 chains to the place of beginning, situated in Marion County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
