CERTIFICATE OF WATER RIGHT

This Is to Certify, That C. J. JENKINS

of Route 1, Independence , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

Rickreall Creek a tributary of Willamette River

for the purpose of

Irrigation under Permit No. 12571 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 12, 1937

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.88 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NWA NEA, Section 33, Township 7 South, Range 4 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

13.9 acres in the SW NW as projected on D.L.C. 48 15.5 acres in the SE NW as projected on D.L.C. 48 25.0 acres in the NE SW as projected on D.L.C. 48 15.4 acres in the NW SW as projected on D.L.C. 48 Section 33, T. 7 S., R. 4 W., W.M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Beginning at a point 11.35 chains North and 8.99 chains East of the quarter corner on the line between Sections 32 and 33 in Township 7 South of Renge 4 West of the Willamette Meridian, in Polk County, Oregon, thence running South 25.01 chains; thence East 8.57 chains; thence South 7.05 chains; thence East 15.05 chains; thence North 71.50 chains; thence North 79° 45' West 4.17 chains; thence North 85° 15' West 4.52 chains; thence South 8.50 chains; thence South 9° East 2.00 chains; thence South 15° 45' West 3.75 chains; thence West 3.22 chains; thence South 25.08 chains to a point 11.04 chains East of the place of beginning; thence West 11.04 chains to the place of beginning.
