CERTIFICATE OF WATER RIGHT

This Is to Certify, That R. F. CLARKE

of Route 1, Box 285, Gaston, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Unnamed tributary a tributary of Tualatin River for the purpose of Irrigation under Permit No. 13179 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 1, 1938

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.04 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 31, Township 1 South, Range 4 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.8 acres in the SW $\frac{1}{4}$  NE $\frac{1}{4}$  as projected on Thomas H. Hines D.L.C. 58  
Section 31,  
T. 1 S., R. 4 W., W.M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows: Beginning at a point on the dividing line and fence between Mary E. Snider's and Pam Patton's land, distant 10.25 chains South from an iron pipe by 30 inch oak post where said dividing line intersects south side of county road, thence East 10 chains at right angles with said dividing line, thence North at right angles 9.75 chains to the South line of the county road, thence East along said South line of County road to the East boundary line of Thomas M. Hines Claim No. 58, thence South 42.55 chains to the south line of section thirty-one, thence West 29.53 chains to iron pipe at 30 inch oak post of dividing line fence, thence North 34.55 chains to the point of beginning; all in section 31, twp one South, Range Four, West of the Will. Meridian, containing 120 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
