that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed C.28 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE_4^1 SE_4^1 , Section 17, Twp. 6 South, Range 3 K., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 0.027 of one cubic foot per second per acre, and shall be further limited to a diversion at the stream of not to exceed one acre foot per acre for each acre irrigated during any 30-day period and shall be limited still further to a diversion at the stream of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year.
