**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That**   ARTHUR KNOX & SONS

of Route 1, Gaston, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Scoggin Creek a tributary of Tualatin River for the purpose of Irrigation under Permit No. 13439 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 13, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.38 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$  of NE $\frac{1}{4}$ , Section 20, Township 1 South, Range 4 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.0 acres in the NE $\frac{1}{4}$  NE $\frac{1}{4}$  as projected on D.L.C. 52  
24.0 acres in the SE $\frac{1}{4}$  NE $\frac{1}{4}$  as projected on D.L.C. 52  
Section 20  
4.0 acres in the SW $\frac{1}{4}$  NW $\frac{1}{4}$  as projected on D.L.C. 52  
Section 21  
T. 1 S., R. 4 W., W.M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Washington, County, Oregon, Being part of the Norman Martin and wife's D.L.C. in T. 1 S. R. 4 W. of Will. Mer., Beginning at the South Westerly corner thereof and running thence South 48° 30' on the Southern boundary line of said Claim 23.90 chains thence North 41° E. 38.65 chains to a post in the center of the County road thence North 51° 30' W. along the center of the County road 23.60 chains to a point on the Western boundary of said Martin's claim, thence South 41° 30' W. 37.39 chains to the place of beginning and containing 90.31 acres of land. Except Beginning at the S.W. corner of Norman Martin and wife's D.L.C. in T. 1 S. R. 4 W. Will. Mer. thence 48° 30' on South boundary of said claim 11 chains, thence North 41° 30' East 23.50 chains to center of Scoggins Creek, thence up said creek course Northwesterly 11 chains more or less to the intersection of West boundary of said claim, thence South 41° 30' West 21.50 chains to the place of beginning; containing 25 acres more or less, which tract was deeded by grantors herein to Anna Marie Stienkemeier, together with a roadway described in said deed.

Also, Beginning at the Northwest corner of the Norman Martin and wife's Donation Land Claim in Section 16, T. 1 S., R. 4 W. of the Willamette Meridian in Washington County, in State of Oregon and running thence South  $48^{\circ} 30'$  E. 23.75 chains to the Northeast corner of the Baker tract, thence South  $41^{\circ} 30'$  W. on his East line 29.50 chains to the center of County Road, thence North  $51^{\circ} 30'$  W. along said County Road 23.45 chains to the West line of said Martin and wife's Donation Land Claim, thence North  $41^{\circ} 11'$  E. on the West line of said claim 30.67 chains to the place of beginning containing 71 acres more or less. Also Lot one (1) and the S. E. quarter of the S.W. quarter of Sec. 16, T. 1 S., R. 4 W. Containing 70.74 acres, being in all 141.74 acres.

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.*
