CERTIFICATE OF WATER RIGHT

This Is to Certify, That GEORGE M. RHEIN

of Route 2, Dayton , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Yamhill River

a tributary of Willamette River

for the purpose of

Irrigation
under Permit No. 13470 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from February 6, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.32 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE NY Section 18, Township 4 South, Range 3 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.7 acres in the NET NET, as projected on D.L.C. 60 0.3 acre in the SWT NET, as projected on f.L.C. 60 11.0 acres in the SET NET, as projected on f.L.C. 60 Section 13
T. 4 S., R. 4 W., W.M.

1.8 acres in the SWA NWA, as projected on D.L.C. 46 5.4 acres in the SEA NWA, as projected on D.L.C. 46 Section 18
T. 4 S., R. 3 W., W.M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Thence along the line common with United States Farm Security Administration
Farm Unit No. 113 as follows; South 75° 42! 00" West 242.35 feet to a point

by a point marked by a 3/4" iron pipe; North 80° 06' 06" West 590.09 feet to
a point marked by a 3/4" iron pipe; South 08° 09' 56" East 505.16 feet to a point marked by a 3/4" iron pipe; North 890 46' 58" West 1316.55 feet to a point marked by a 3/4" iron pipe: North C7° 30' 18" West 1342.15 feet to a point marked by 3/4" iron pipe on the South line of Farm Unit No. 37; Thence North 89° 22' 16" West 2180.13 feet along the South line of Farm Unit No. 37 to a print in the Yamhill River on the West line of the Francis Fletcher Donation Land Claim, said point being witnessed by 3/4" iron pipes set back on line 100.00 feet and 200.00 feet; Thence South COO 11' 41" West 111.95 feet along said Claim line to an angle corner in said Claim line, said point being in the Yamhill River Thence South 88° 21' 15" East 151.39 feet along said Claim line to the point of beginning. This Unit contains 73.919 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
