CERTIFICATE OF WATER RIGHT

This Is to Certify, That RALTER DOZLER

of Scio , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Bear Branch

a tributary of North Santiam

for the purpose of

Irrigation under Permit No. 13478 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 8, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.05 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SW NW NW Section 25, Township 9 South, Range 1
West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightleth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shal

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.4 acre in the NW1 SW1 Section 25
3.2 acres in the NE1 SE4 Section 26
T. 9 S., R. 1 W., W.M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Beginning at a point 3.13 chains East of the quarter section corner between sections 25 and 26 in Township 9, South of Range 1 West of the Willamette Meridian, Oregon, and running thence South 22% East 9.25 chains; thence South 15.88 chains; thence West one chain; thence South 15.37 chains to the South line of section 25; thence West 45.73 chains to the quarter section corner between Sections 26 and 35 in said township; thence North 40 chains; thence East 43.13 chains to the place of beginning, containing 183.86 acres, more or less, in Linn County, Oregon.

Save and except the following; Beginning at the Southwest Corner of the Southeast quarter of Section 26, in township 9, South of Range 1 West of the Willamette Meridian, Linn County, Oregon, thence running North 7.20 chains to the center of a ditch; thence following the center of said ditch up stream in a south and easterly direction to its intersection with the South boundary of said Section 26; thence West 30 chains to the place of beginning, containing 11.8 acres.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
