CERTIFICATE OF WATER RIGHT

This Is to Certify, That AMOS O. HENTON

of Route 1, Sheridan, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Yamhill River a tributary of Yamhill River for the purpose of Irrigation under Permit No. 13538 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 27, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.30 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 33, Township 5 South, Range 6 West,

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

15.4 acres in Lot 3 (NE $\frac{1}{4}$ SW $\frac{1}{4}$)
8.0 acres in Lot 2 (NW $\frac{1}{4}$ SW $\frac{1}{4}$)
Section 33
T. 5 South, R. 6 West, W. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows: Beginning at the Northeast corner of the B. B. Branson D.L.C. #37, in T. 5 S., R. 6 W., W. M., in Yamhill County, Oregon; thence West 14.32 chains to a stake; thence North 11° 15' West 13.46 chains to a stake; thence North 39° West 31.80 chains to a point in the Yamhill River opposite the mouth of Mill Creek; thence North 51° East to the Southwest corner of the John P. Wood D.L.C. #44, T. 5 S., R. 6 W., W.M.; thence North 75° East on South boundary of said claim 25.72 chains; thence South 5° East 14.91 chains to the Northeast corner of the I. N. Branson D.L.C.; thence West 19.95 chains to the Northwest corner of the said I. N. Branson D.L.C.; thence South 19 chains to the place of beginning; containing 68 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
