CERTIFICATE OF WATER RIGHT

This Is to Certify, That GEO. L. HENDRICKS

of Forest Grove , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Gales Creek a tributary of Tuelatin River for the purpose of

Irrigation under Permit No. 15209 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 5. 1942

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.62 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SWNE & SENW, Section 1, Township 1 South, Range 4 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.9 acres in the NW NE₁, as projected on D.L.C. 37
12.3 acres in the SW; NE₁, as projected on D.L.C. 37
1.7 acres in the NE₁ NW, as projected on D.L.C. 37
2.1 acres in the SE₂ NW, as projected on D.L.C. 37
3.6 acres in the NE₁ SW, as projected on D.L.C. 37
0.9 acres in the SE₂ SW, as projected on D.L.C. 37
17.0 acres in the NW, SE₄, as projected on D.L.C. 37
7.6 acres in the SW, SE₄, as projected on D.L.C. 37

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

The following portion of the T. G. Naylor D.L.C. No. 37, T. 1 S., R. 4 W. Will. Mer.: Commencing 30 feet south of the southeast corner of the Donation Land Claim of Henry Buxton, Sr. in Section 1, T. 1 S. R. 4 W. Willsmette Meridian, and running thence south 83° 56' East 10.53 chains; thence south 45' West 70.96 chains to the south line of the said Naylor D.L.C.; thence North 69° 30' West 10.72 chains; and thence North 45' east 68.38 chains to the place of beginning containing 72.20 acres and marked and designated on plat of reference as Lot C Circuit Court record Vol. 5 page 45, Dec. 2nd, 1892. Excepting and saving therefrom that certain tract of land conveyed by George 0. Sloan and wife to A. B. Caples, said conveyance being recorded at page 413 of Book of Records of Deeds for Washington County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
