CERTIFICATE OF WATER RIGHT

This Is to Certify, That MATTHEW and/or HATTIE KING

of Mist Route, Vernonia , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Nehalem River

a tributary of Irrigation

for the purpose of

under Permit No. 13869 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 19, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.23 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW4 NE4, Section 34, Township 5 North, Range 4 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightleth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

7.5 acres in the NW1 NE1
5.5 acres in the SW1 NE1
0.2 acre in the NE1 NW1
4.8 acres in the SE1 NW1
Section 34
T. 5 N., R. 4 W., W.M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Beginning at the southwest corner of the southeast quarter (SE_4^1) of the northwest quarter (NW_4^1) of Section 34 of Township 5 North, Range 4 West of the Willamette Meridian; thence North following the West boundary line of the southeast quarter (SE_4^1) of the Northwest quarter (NW_4^1) to its intersection with the easterly edge of the Nehalem Highway as now surveyed and located; Thence in a Northeasterly direction following the easterly edge of said highway to the center of the Nehalem River, thence down the center of Nehalem River in a Southeasterly direction, to its intersection with the east line of the West half (N_2^1) of the Northeast quarter (NE_2^1) of Section 34 said Township and Range; Thence South on East boundary line of said West one half of Northeast quarter to the center line running East & West through said section 34; thence West on center line to place of beginning containing 85 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
