This Is to Certify, That ERNEST STADELI

State of Oregon , has made proof of Route 3, Silverton to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Pudding River and Drift Creek a tributary of

under Permit No. 14522 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 5, 1940

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed C.44 cubic foot per second, being C.38 c.f.s. from Pudding River and C.06 c.f.s. from Drift Creek.

or its equivalent in case of rotation, measured at the point of diversion from the stream. West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second peracre, or its equivalent To: each acre irrigated and shall be further limited to a diversion of upt to exceed 21 acre feet per acre for each acre irrigated during the irrigation ceasem of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1 Pl of 16 p. 185 6.0 acres in the NE NE 26.8 acres in the NW NE 1.8 acres in the Lot 4 (NENW) Section 8 T. 7 S., R. 1 W., W.M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

A tract of land consisting of eight (8) acres, more or less said tract of land being four (4) chains wide and twenty (20) chains long of of the East end of the East one-half $(E.\frac{1}{2})$ of the following described Forty (40) acre tract of land; the North one-half $(N,\frac{1}{2})$ of the fractional East half $(E,\frac{1}{2})$ of the North West one-fourth (N.W.1) of Section eight (8) in T. 7, S. R. I W. of the Willamette Meridian, the same being designated in the plat of public surveys as Lot number three (3) of aforesaid Section 8, more particularily described as follows, to-wit: Commencing at the one quarter Section corner between Sections 5 and 8 in the aforesaid Township; thence West to a point in the East boundary of the D. L. C. of Thomas C. Shaw and wife in said Township 7; thence South along East boundary of said Shaw Claim 20.00 chains to the legal sub-division line; thence East to the legal sub-division line that divides said Section 8 into East and West halves; thence North 20.00 chains to the place of beginning and containing 40 acres of land mo ; or less, situated in Marion County, State of Oregon.

Commencing at the northeast corner of the southwest $\frac{1}{4}$ of the northeast $\frac{1}{4}$ of Section 8, Township 7, S. R. 1 W. Willamette Meridian, Marion County, Oregon, running thence east 2 rods; thence north 42 rods; thence east 58 rods; thence north 38 rods; thence west 120 rods; thence south 80 rods; thence east 80 rods to the place of beginning and containing 80 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
