CERTIFICATE OF WATER RIGHT

This Is to Certify, That HARRY K. & LUTITIA C. BAUGHN

of McMinnville, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Hayes Creek a tributary of Yamhill River for the purpose of Irrigation under Permit No. 13967 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 11, 1939.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.06 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 24, Township 2 South, Range 5 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 1.3 acres in the NW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on D.L.C. 41
- 2.9 acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on D.L.C. 41
- Section 24
- T. 2 S., R. 5 W., W.M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Being a part of the Elijah Dodson D.L.C. Notification #2846, Claim #41, in Township 2 South, Range 5 West of the Willamette Meridian, in Yamhill County, Oregon, and beginning at the iron pipe set on the East line of said Dodson Claim at point S. 00° 47', East 20.927 chains from the N. W. corner of the M. R. Crisp Donation Land Claim, and said corner being also the Southeast corner of lot 7 of County Survey No. 2222. thence S. 00° 47', east along the east line of the Elijah Dodson Claim 19.667 chains to an iron pipe set for compromise Corner between the Obye Heirs and Wm. Shepherd said point being 55 links North and 137 links east of stone set by Burnson in former survey for the southeast corner of said Elijah Dodson Claim, and also 55 links south and 54 links east of large irregular stone marked H. D. set by Frazier in County Survey #662 for said southeast corner of Elijah Dodson Claim thence S. 88° 53' West along compromise line between Obye Heirs and Shepherd 18.917 chains to iron pipe set for S. W. Corner of lot 8 and S. E. corner of lot 10, said Survey #2222; thence N. 14° 55', W. between lots 8 and 10, 14.045 chains to iron pipe; thence N. 43° 27' W. 8.903 chains to iron pipe at the N. W. corner of Lot 8 and S. W. Corner of lot 7; thence east between lots 7 and 8, 28.382 chains to beginning and containing 44.07 acres more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
