CERTIFICATE OF WATER RIGHT

This Is to Certify, That GEO. H. KRUSE

of Mt. Angel, , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

Abiqua Creek a tributary of Pudding River

for the purpose of

Irrigation
under Permit No. 14182 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from January 30. 1940

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.19 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW_4^1 NW_4^1 , Section 24, Township 6 South, Range 1 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.6 acres in Lot 4 (SWSW)

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows: Beginning at the S.W. Corner of the Jesse F. Walker D.L.C. in T. 6 S. R. 1 W., Marion County, Oregon: thence N. 1 degree and 10 minutes W. along the West line of said D.L.C. 17.40 chains; thence S. 88 degrees and 37 min. E. along the S. line of the Benedictine Father's land 13.97 chains to the quarter section corner on the W. line of section 13; thence S. 89 degrees and 29 min. E. 10.30 chains to an iron bar in the center line of the county road; thence S. 2 degrees and 58 min. W. along the center line of said road 23.52 chains to a stone in the S. line of the Jesse F. Walker D.L.C.; thence N. 73 degrees and 58 min. W. along said S. line 23.594 chains to the point of beginning; containing 48.02 acres of land.
