**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** KARL DETTWYLER

of Route 2, Silverton, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Pudding River a tributary of Molalla River for the purpose of Irrigation under Permit No. 14365 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 6, 1940

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.03 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Any point on ~~my~~ property where Pudding River touches it in NE $\frac{1}{4}$  NE $\frac{1}{4}$  & SE $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 6, Township 7 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.3 acres in the NE $\frac{1}{4}$  NE $\frac{1}{4}$  as projected on D.L.C. 52  
0.8 acre in the SE $\frac{1}{4}$  NE $\frac{1}{4}$  as projected on D.L.C. 52  
Section 6  
T. 7 S., R. 1 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Commencing at a point in the East boundary line of the D.L.C. of Wesley Shannon and wife in T. 7 S., R. 1 W. of Willamette Meridian, said commencing point is in the middle of Pudding River and S. 1° 50' East 12.54 chains distant from the most easterly northeast corner of said D.L.C.; thence meandering said river upstream as follows, to wit: N. 70° 5' West 2.59 chains; N. 82° 50' West 4.30 chains; S. 69° 55' West 1.41 chains; S. 66° 25' West 2.05 chains; S. 61° 0' West 2.11 chains; S. 57° 5' East 1.96 chains; S. 61° 15' East 2.34 chains; S. 48° 0' East 2.70 chains; S. 16° 20' East 1.45 chains; S. 41° 15' West 1.40 chains; S. 35° 35' East 4.30 chains; S. 70° 5' East 1.57 chains; S. 41° 30' East 96 links; S. 79° 0' East 2.75 chains to a point in the middle of said Pudding River where the east line of aforesaid D.L.C. again crosses said river; thence N. 1° 50' West 13.15 chains to the place of beginning, containing ten (10) acres of land, more or less, and situated in Marion County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
