CERTIFICATE OF WATER RIGHT

This Is to Certify, That C. H. COYLE

State of Oregon of St. Paul , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Willamette River

a tributary of Columbia River

for the purpose of

Irrigation

under Permit No. 14369 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 10, 1940

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.58 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 6 (NM SEL, NEL, SEL), Lot 5 (SM SEL, SEL, SEL), Section 26, Township 4 South, Pange 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eigntieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: 12.3 acres in the NNA SNA as projected on D.L.C. 65 3.0 acres in the SNA SNA as projected on D.L.C. 65

1.5 acres in Lot 6 (NE) SEA)

23.1 acres in the NE SE as projected on D.L.C. 65

0.3 acre in Lot 5 (SE SE)

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows: The extreme West 46 acres of the following described tract: Beginning at the Northwest corner of Michael Coyles Donation Land Claim in Section 20, Township 4 South, Range 3 West of the Willamette Meridian, Marion County, State of Oregon; running thence South 19.80 chains; thence East 120.82 chains; thence North 8º East 20.42 chains; thence West 123.50 chains to the place of beginning, containing 241.80 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
