## **CERTIFICATE OF WATER RIGHT**

## This Is to Certify, That R. S. McLOUD

of Box 57, Marion , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of An Unnamed Slough

a tributary of North Santiam

for the purpose of

Irrigation

under Permit No. 14463 of the State Engineer, and that said right to the use of said waters k—s been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 2, 1940

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed C.30 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SK2 NF2, Section 4, Township 10 South, Renge 2 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 23 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

11.1 acres in the SW $\frac{1}{4}$  NE $\frac{1}{4}$ , as projected on D.L.C. 55 12.5 acres in the NW $\frac{1}{4}$  SE $\frac{1}{4}$ , as projected on D.L.C. 55 Section 4

Township 10 South, Range 2 West, W.M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows: Beginning at the Northeast corner of the Donation Land Claim of William W. McKinney and Matilda McKinney, his wife, Notification No. 1855 Claim No. 55 in Township 1C South, Range 2 West of the Willamette Meridien, Oregon, and running thence Westerly on and along the Northern boundary line of said Donation Land Claim a distance of 16 chains, thence South 33 chains to the Santiam River, thence Easterly following the meanderings of said Santiam River to the East boundary line of said Donation Land Claim, thence North on the East boundary line of said Donation Land Claim, thence North on the East boundary line of said Donation Land Claim 25 chains to the place of beginning, containing 46.25 acres, more or less, in Merion County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
