# CERTIFICATE OF WATER RIGHT

This Is to Certify, That FRED STADELI

of Route 3, Silverton, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Pudding River a tributary of Molalla River for the purpose of Irrigation under Permit No. 14527 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 6, 1940

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.38 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 5, Township 7 South, Range 1 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

9.0 acres in the NW $\frac{1}{4}$  SE $\frac{1}{4}$   
21.0 acres in the SW $\frac{1}{4}$  SE $\frac{1}{4}$   
Section 5  
T. 7 S., R. 1 W., W.M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Commencing at the S. E. corner of the S. W. quarter ( $\frac{1}{4}$ ) of the S. E. quarter ( $\frac{1}{4}$ ) of Section 5 T. 7 S., Range 1 West of the Willamette Meridian, Marion County State of Oregon thence North 30.00 chains to the South line of the railroad right of way.

Thence Southwesterly along said Railroad right of way 22.00 chains to the west line of said S. E. quarter ( $\frac{1}{4}$ ) of Section 5 thence South 10.00 chains to the North line of land owned by D. F. Hillman thence East 10.00 chains to the N. E. Corner of said Hillman tract thence South 12 chains to the center of the county road thence East along the center of said road 10 chains to the place of beginning and containing 40 acres of land, more or less. All situated in said Section 5, T. 7 S., R. 1 West of the Willamette Meridian Marion County, State of Oregon.

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.*
