CERTIFICATE OF WATER RIGHT

This Is to Certify, That JOHN H. FICK

of Route 2, Silverton , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Pudding River a tributary of Molalla River, tributary of Willamette River for the purpose of Irrigation under Permit No. 14385 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 23, 1940

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.25 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ NE $\frac{1}{4}$ & NW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 20, Township 6 South, Range 1 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.0 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on D.LC 55
5.9 acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on D.LC 42
1.2 acres in Lot 2 (NE $\frac{1}{4}$ SW $\frac{1}{4}$)
6.9 acres in Lot 1 (NW $\frac{1}{4}$ SE $\frac{1}{4}$)
Section 20
T. 6 S., R. 1 W., W.M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows: Beginning in the middle of the County Road, at a point 43.42 chains North 89° 28' East and 22.116 chains North from the Northeast corner of Lot No. 1 of section 30 in T. 6 S. R. 1 W. of the W.M. in Marion County, Oregon; and from thence running North 12° 30' West 14.629 chains along the middle of the County Road; thence North 71° 30' East 7.38 chains; thence North 49° 45' East 14.15 chains to the middle of Pudding River; thence Southerly following the meanderings of said river up stream, to a point in the middle of said river that is 23.00 chains North 80° 04' East of the place of beginning; thence South 80° 04' West 23.00 chains to the place of beginning and containing 40.57 acres of land.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
