CERTIFICATE OF WATER RIGHT

This Is to Certify, That FRITZ VON ALLMEN & CARL BARDELL

of Goble , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a Spring

a tributary of Columbia River

for the purpose of

Domestic Use under Permit No. 14557 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 21. 1940

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE₄ NE₄, Section 14, Township 6 North, Range 2 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - - - of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Domestic Use in the SW4 NW4 Section 13 T. 6 N., R. 2 W., W.M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

(Carl Bardell Property) ALSO, beginning at a point on Section line between Section 13 and 14, Township 6 North Range 2 West of Willamette Meridian, that is 101.26 rods South from northwest corner of Section 13, Township 6 North of Range 2 West of Willamette Meridian, thence North on said line 208 feet; thence East to center of County Road; thence southerly following said line of County Road to point directly east of place of beginning; thence west to place of beginning.
ALSO, beginning at a point on Section line between Sections 13 and 14, Township 6 North, Range 2 West of Willamette Meridian, 101.26 rods South from the northwest corner of Section 13, Township 6 North, Range 2 West of Willamette Meridian; thence South 60 feet on said line; thence East to center of County Road; thence northerly following said line of said road to a point directly east of place of beginning, thence west to place of beginning.

(Fritz Von Allmen Property) Commencing at a point on the Section line between the Northwest Quarter of Section 13, and the Northeast Quarter of Section 14, Township 6 North of Range 2 West of the Willamette Meridian, which said point is 60 feet South of the Southwest corner of a 3-acre tract in said Northwest Quarter of said Section 13 belonging to E. W. Fowler; running thence East parallel with the South boundary line of said 3-acre tract to present course of St. Helens County Road; thence following the meanders of said road in a Southeasterly direction to Northeast corner of a piece of land in the Southwest Quarter of said Section 13 owned by W. M. Jordan, said point being the Northeast corner of the Northwest Quarter of the

Southwest Cuarter of said Section 13; thence West along Northern boundary line of said land owned by W. M. Jordan to Southwest corner of Southwest Cuarter of the Northwest Cuarter of said Section 13; thence North along the Section between the Northwest Cuarter of said Section 13 and the Northeast quarter of said Section 14 to point of beginning, all of said property being in the Southwest Cuarter of the Northwest Cuarter of Section 13, Township 6 North of Range 2 West of the Willamette Meridian, Columbia County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
