**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** CHAS. O. & LYDA A. EDWARDS

of Route 2, Box 90, McMinnville, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Unnamed Stream a tributary of North Yamhill River for the purpose of Irrigation under Permit No. 14575 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 3, 1940

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 10, Township 4 South, Range 4 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.7 acre in the SE $\frac{1}{4}$  NE $\frac{1}{4}$ , as projected on Milcs Carey D.L.C. 44  
0.1 acre in Lot 1 (SE $\frac{1}{4}$  NE $\frac{1}{4}$ )  
Section 10  
T. 4 S., R. 4 W., W.M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Beginning at a stone at the Northwest corner of the Joseph R. Young Donation Land Claim, Notification No. 1231, Claim No. 68, in Section 10 in Tp. 4 S. R. 4 W. of the Willamette Meridian, in Yamhill County, State of Oregon, and running thence South 2° 06' West along the West line of said claim at 8.95 chains intersect iron pipe at the Northeast corner of the Madison Malone Claim 21.00 chains to the center of the North Yamhill River; thence South 51° 22' East along the center of river 2.25 chains to angle in river; thence North 17° 57' East along center of river 8.98 chains to angle in river; thence North 77° 56' East along center of river 12.60 chains to angle in river and South line produced to river; thence South 84° 27' East leaving river and along old fence between Riis and Jacobsen lands 12.00 chains to center of County road; thence North 19° 40' West along center of road 4.81 chains to angle in road; thence North 35° 46' West along center of road 6.23 chains to angle in road; thence North 26° 04' West along center of road 3.10 chains to point in center of road in line with the North line of the Young claim produced East; thence West along line of Young and Tustin claims 21.39 chains to the place of beginning and containing 37.50 acres more or less.

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.*
