**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That WILFORD A. NELSON**

of Route 2, Woodburn, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rock Creek, a tributary of Pudding River, for the purpose of Irrigation under Permit No. 14618 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 16, 1940

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.38 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 7, Township 5 South, Range 1 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.9 acres in the NE $\frac{1}{4}$  SE $\frac{1}{4}$   
3.3 acres in the SW $\frac{1}{4}$  SE $\frac{1}{4}$   
24.8 acres in the SE $\frac{1}{4}$  SE $\frac{1}{4}$   
Section 7  
T. 5 S., R. 1 E., W. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Part of the Southeast Quarter (SE $\frac{1}{4}$ ) of Section 7, Township 5 South, Range 1 East, of the W. M. Beginning at a point 2.72 chains North of the Southeast corner of said Section 7; thence North 18.62 chains; thence West about 19.00 chains to the middle of the County road; thence southerly in said road 18.62 chains more or less, to a point 27.00 chains West of the place of beginning; thence East 27.00 chains, more or less to the place of beginning; containing 45 acres, more or less, save and except a right-of-way conveyed to Records of Clackamas County, Oregon, being part of the D.L.C. of I. D. Murray and Maria T. Murray, his wife, situated in the County of Clackamas and State of Oregon. Records recorded in Records of Deeds of Clackamas County, Oregon.

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.*
