CERTIFICATE OF WATER RIGHT

This Is to Certify, That E. A. AND GLADYS HARNSBERGER

of Independence, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Unnamed Slough a tributary of Rickresall Creek for the purpose of Irrigation under Permit No. 14799 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 13, 1941

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.25 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 10, Township 8 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.5 acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$ as projected on D.L.C. 67
3.1 acres in the SE $\frac{1}{4}$ SW $\frac{1}{4}$ as projected on D.L.C. 67
Section 3
1.0 acre in the NW $\frac{1}{4}$ NE $\frac{1}{4}$
9.7 acres in the NE $\frac{1}{4}$ NW $\frac{1}{4}$
1.1 acre in the NE $\frac{1}{4}$ NW $\frac{1}{4}$ as projected on D.L.C. 55
1.0 acre in the NW $\frac{1}{4}$ NW $\frac{1}{4}$ as projected on D.L.C. 55

T. 8 S., R. 4 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Beginning at a point 9.10 chains West of the Southeast corner of the John T. Davis Donation Land Claim No. 67, Not. No. 1516, in Township 8 South Range 4 West of the Willamette Meridian in Polk County, Oregon; thence North 7.00 chains; thence South 89° 45' West 3.66 chains to the center of the County Road; thence Southeasterly along the center of said road 16.92 chains; thence South 1.10 chains to the North line of the Elzy C. Dice Donation Land Claim No. 55 in said Township and Range; thence North 89° 49' East 11.93 chains; thence South 5.00 chains; thence East 6.00 chains to the East line of said Dice Claim; thence South 9.00 chains; thence North 55 East 24.41 chains to a point on the North line of Hiram S. Young's Claim in said Township and Range, which point is 20.00 chains East of the Northwest corner of said Young Claim; thence West about 16.30 chains to the place of beginning, containing 24.50 acres, more or less.

Beginning at a point on the east boundary of the State Highway, Brunk's Corner to Independence, at 51.5 feet south 46 10' east from the southwest corner of the Catherine Fudge D. L. C. Not. No. 60 in T. 8 S., R. 4 W. of the Willamette Meridian in Polk County, Oregon, thence south 48 45' east 251 feet to the center-line of the old county road; thence along the center line of old road south 58 0' west 195 feet, south 65 0' west 411 feet, south 78 0' west 445 feet to the southeast boundary of the said state highway; thence along the easterly boundary of said highway north 55 50' east 948 feet to the place of beginning containing 3.60 acres.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
