CERTIFICATE OF WATER RIGHT

This Is to Certify, That ED SOHRWELD

of 16-1st West, Tillamook , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Yamhill River

a tributary of Willamette River

for the purpose of

Irrigation
under Permit No. 14826 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from April 4, 1941

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.17 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW4 NE4, Section 22, Township 4 South, Range 4 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

8.0 acres in the NW $_{4}^{+}$ NE $_{4}^{+}$, as projected on D.L.C. 52 3.6 acres in the SW $_{4}^{+}$ NE $_{4}^{+}$, as projected on D.L.C. 52 1.3 acres in the NE $_{4}^{+}$ NW $_{4}^{+}$, as projected on D.L.C. 52 0.7 acre in the SE $_{4}^{+}$ NW $_{4}^{+}$, as projected on D.L.C. 52 Section 22

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Beginning at the Northwest corner of the Donation Land Claim of Isaish M. Johns and wife, Claim No. 81 in Township 4 South, Range 4 West of the Willamette Meridian, in Yamhill County, Oregon, and running thence South 18.56 chains; thence South 89° 25' East 29.68 chains to the center of the Yamhill River, thence up said river with its meanderings to its intersection with the South line of the Vincent Snelling Donation Land Claim at a point 4.73 chains East of the Southwest Corner of said Vincent Snelling Claim, thence East 3.27 chains to angle corner of said Vincent Snelling Claim, thence South 51° East 5.75 chains to the place of beginning and being a part of the Vincent Snelling and Isaiah M.
