Irrigation under Permit No. of the State Engineer, and that said right to the use of said waters 14865 has been perfected in accordance with the laws of Oregon; that the pric ity of the right hereby confirmed dates from April 14, 1941

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.31 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW NW NW Section 17, Township 4 South, Range 3

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Commencing at a stone at the N.E. corner of that tract of i conveyed by deed from A. P. Kempton and Helen Kempton his wife to Louis Howarth and Anna C. Howarth, his wife and recorded in Book 82, page 340 deed records of Yamhill County, Oregon and running thence S. 27° W. along the Easterly line of eforesaid Howarth tract, said line being also the Easterly line of the Franklin Martin D.L.C. #45, a distance of 2007 feet to a point on the North Bank of the Yamnill River which is the S. E. corner and true beginning point of the land herein described; Running thence from said true beginning point N. 27° E. 908.55 feet to an iron pipe which is S. 27° W. 1098.45 feet from the N.E. corner of the before mentioned Howarth tract; Running thence from said iron pipe Westerly 1768.8 feet to a point in the Westerly line of hereinbefore mentioned Howarth tract at a point which is Southerly 798 feet from a stone monument at the Westerly N.W. corner of said Howarth tract. Running thence from said point Southerly and following the Westerly line of aforesaid Howarth tract 689.6 feet to the North Bank of Yamhill River thence following the meanderings of said river S. 87° 30° E. 163.3 feet; thence S. 80° E. 1203.84 feet more or less to the place of beginning containing 27.7 acres more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
