This Is to Certify, That HM. ROSENBALM

of Route 1, Sheridan , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Will Creek

a tributary of Yamhill River

for the purpose of

and shall

Irrigation under Permit No. 14869 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 16, 1941

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed C.15 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the $NN_{\frac{1}{2}}^{\frac{1}{2}}$, Noses Eades D.L.C. No. 39, Section 9, Township 6 South, Range 6 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of our cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feat per acre for each acre irrigated during the irrigation season of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

> 4.0 acres in the NE⁺₄ NE⁺₄, as projected on D.L.C. 39
> 8.0 acres in the SE⁺₄ NE⁺₄, as projected on D.L.C. 39 Section 8
> T. 6 S., R. 6 W., W.M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Beginning at an iron pin in the Moses Fade D.L.C. Not. 4987, Claim 39, 3.69 chains West and 28.51 chains South OO degrees 26 min. East from the Southeast corner of the B. B. Branson D. L. C. Not. 4963, Claim 65 in T. 6 S. R. 6 W. of the Willamette Meridian in polk County, Oregon, thence West 5.00 chains to an iron pin, thence North OO degrees 26 min. West 5.00 chains to an iron pipe, thence West 14.88 chains to an iron pipe, thence South 18.30 chains to a stake, thence East 1.56½ chains to a stake, thence South 18.30 chains to a stake, thence East 1.56½ chains to a stake, thence South 34 degrees East 1.47 chains to a stake; thence East 17.64 chains to a stone, thence N. CO degrees 26 min. West 14.50 chains to the place of beginning, containing 36.17 acres, more or less, except a roadway now there 25 feet wide off the East side and 11 feet wide off the South side containing 81/100 acres, leaving 35.36 acres in the above described tract.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
