CERTIFICATE OF WATER RIGHT

This Is to Certify, That IRMA GRACE TURNER

of c/o State Hospital, Salem, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Unnamed Spring a tributary of Winslow Creek, Willamette River, for the purpose of Domestic, including the irrigation of a garden and lawn not exceeding 1/2 acres in area under Permit No. 14873 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 17, 1941

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 8, Township 7 South, Range 3 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - - of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

SE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on D.L.C. 65
Section 8
T. 7 S., R. 3 W., W.M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Beginning at an iron pipe 31.00 chs. east and 18.25 chs. north from the rock at the Southwest corner of the C. O. Hosford D.L.C. Not. No. 137, Cl. No. 65 in section 17 of T. 7 S. R. 3 W. of the Willamette Meridian in Polk County, Oregon, thence north 18.78 chs. to the middle of the county road, Salem to Zena, from which point an iron pipe is south on the south side of the road; thence along the center of the road N. 71° 15' W. 2.00 chs.; N. 61° 0' W. 6.7 chs.; N. 64° 0' W. 50 links to a point in center of road from which point an iron pipe is south on the south side of the road; thence South 22.65 chs. to an iron pipe; thence east 2.23 chs. to the place of beginning, containing 17.04 acres.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
