CERTIFICATE OF WATER RIGHT

This Is to Certify, That E. C. SAMMONS

of 4784 S.E. 17th Ave., Portland , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Willamette River

a tributary of Columbia River

for the purpose of

Irrigation
under Permit No. 14901 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from May 5, 1941

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.06 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NN_4^+ NE_4^+ , Section 6, Township 4 South, Renge 1 West, W. M., in Jos. C. Geer D.L.C.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Lend on which water is to be used is a part of the property more explicitly described by appropriator as follows:

All the East half of the following described real property lying in Yamhill and Clackemes Counties, State of Oregon, and being a part of the J. C. Geer Donation Land Claim Notification No. 1090, Claim No. 37 in T. 3 S., R. 1 W. of W. M. and Claim No. 38 in Township 4 South, Range 1 West of W. M. and beginning at an iron pipe 1 inches by 36 inches set on north line of dower as set off in Yamhill County survey #1624, said point being 52.32 chains South 33° 15' East and North 56° 00' East 19.215 chains from the northwest corner of said Geer Donation Land Claim; thence North 56° 00' East along the north line of said dower 11.83 chains to an iron bolt 1 inch by 30 inches and marked by a fir 30 inches in diameter bears South 11° 45' East 45 links; thence South 330 15' East parallel with the west line of said lower 30.326 chains to an iron bar 1 inch by 24 inches for witness corner from which a black walnut 30 inches in diameter beers North 34° 00' East 99.50 links, 33.248 chains to water's edge on North bank of Willamette River; thence up stream on left bank of river south 52° 48' West 5.647 chains, South 45° 01' West 6.187 chains; South 46° 05' West, .137 chains, southwest corner of this tract; and southeast corner of 30 acre tract; thence North 33° 15' West parallel with west line of said dower, on top of bank set iron pipe 12 inches by 24 inches for line from which a maple 8 inches in diameter bears South 240 201 West 8.50 links, 34.764 chains to the place of beginning, being situated in the County of Clackemas and County of Yamhill, in the State of Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
