CERTIFICATE OF WATER RIGHT

This Is to Certify, that WALTER NILLER

ofRoute 1, Box 251-A, Oregon City , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Unnamed Creek

a tributary of Beaver Creek Irrigation

for the purpose of

under Permit No. 14969 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 17, 1941

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.09 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NW NEX, Section 13, Township 3 South, Range 1 East,

W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shal

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.3 acres in the NW NE NE 14.7 acres in the SW NE NE 15.7 NE 1

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

A part of S. S. White D.L.C. No. 42 in T. 3 S., R. 1 E. of the W. M., in the County of Clackamas and State of Oregon described as follows:

Beginning at a point 9.60 chains North 42° 30' East and South 45° 45' East 835.5' from the most westerly corner of the S. S. White D.L.C. No. 42 in Section 13, T. 3 S., R. 1 E. of the W. M., and running thence South 45° 45' East 335 to an iron pipe; thence South 89° 01' East 1201.4 feet to an iron pipe; thence North 3° 23' East 392 feet more or less to the Northeasterly corner of that certain tract conveyed to A. S. Welch, et ux, by deed recorded February 21, 1939 in Book 255 page 938; thence North 47° 30 W. 927 feet; thence in a Southwesterly direction to place of beginning excepting therefrom a roadway 20 feet wide the center line which is described as follows:

Beginning at 10 feet South 44° 10' West from the most northerly corner of the above described piece of land, and running thence South 47° 30' East 376 feet; thence South 7° 37' East 133 feet; thence South 30° 02' East 157 feet; thence South 58° 02' East about 20 feet to the county road and except that portion in roads.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
