## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** E. L. VAN DYKE

of Dundee, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Unnamed Creek a tributary of Willamette River for the purpose of Irrigation under Permit No. 14979 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 10, 1941

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.16 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the  $SW\frac{1}{4} SW\frac{1}{4}$ ,  $SE\frac{1}{4} SW\frac{1}{4}$ , Section 36, Township 3 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.5 acres in the  $NE\frac{1}{4} NW\frac{1}{4}$  as projected on D.L.C. 72  
5.1 acres in the  $NW\frac{1}{4} NW\frac{1}{4}$  as projected on D.L.C. 72

T. 4 S., R. 3 W., W. M.

4.7 acres in the  $SE\frac{1}{4} SW\frac{1}{4}$  as projected on D.L.C. 70  
Section 36  
T. 3 S., R. 3 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Twenty acres off the West side of the following described real estate, to-wit: Being a part of the Donation Land Claim of Seawood Fullquarts and wife, Claim No. 70 and 72, Notification No. 1044, in Townships 3 and 4 South of Range 3 West, in Yamhill County, State of Oregon, and bounded as follows: Beginning on the Township line between Townships 3 and 4 South of Range 3 West of aforesaid at a point where said line runs into the Willamette River; thence West 20.00 chains; thence North  $20^{\circ}$  East 21.00 chains; thence East 20.00 chains to the Willamette River; thence Southwesterly along the river bank to the place of beginning, containing 40 acres, more or less. And also the following described tract adjoining said tract above described on the South thereof, to-wit: Beginning on Township line at a stake 20.08 chains North  $89^{\circ} 30'$  East of the Southwest Corner of Section 36, Township 3 South of Range 3 West in said County and State; thence South  $21^{\circ}$  West 6.00 chains to a stake; thence North  $89^{\circ} 30'$  East 16.57 chains to a stake on West side of the Narrow Gauge Railroad track; thence North  $44\frac{1}{4}^{\circ}$  East along said track 2.66 chains; thence North  $33^{\circ} 45'$  East 2.50 chains to a stake on Township line; thence South  $89^{\circ} 30'$  West 18.80 chains to a stake

to the place of beginning, containing 10 acres, more or less. The intention being to include by the above description 20 acres off the West side of the two tracts above described and of uniform width.

Also: A part of the Donation Land Claim of Seawood Fullquarts and wife, Claim No. 70 and 72, Notification No. 1044, Township 3 and 4 South of Range 3, West of the Willamette Meridian, and beginning at the Northeast Corner of that tract of 75 acres of land owned by E. B. and O. K. Williamson, purchased by them of S. A. Fullquarts; thence West on the Township line 38 rods to the Narrow Gauge Railroad track; thence Southerly and parallel with said railroad track 21 rods to the center of the County road now there; thence Easterly along the center of said road, 31 rods and 5 feet to the Southwest Corner of ten acre tract formerly owned by said Williamson; thence Northerly along West line of said ten acre tract 22 rods and 8 feet to the place of beginning, containing 5 acres, more or less, in the County of Yamhill, State of Oregon.

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.*
