CERTIFICATE OF WATER RIGHT

This Is to Certify, That NEAL W. HAZLETON

of Dundee , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Unnamed Stream a tributary of Chehalem Creek for the purpose of Irrigation under Permit No. 15072 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 30, 1941

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.04 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 4 of Hobsons Fruitland subdivision being within SW1 NW1, Section 24, Township 3 South, Renge 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.7 acres in the Sai Nul Section 24 T. 3 S., H. 3 N., W. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows: Being a part of the D.L.C. of Andrew Harvey, in T. 3 S., R. 3 W. of the Willamette Moridian, in Yamhill County, and State of Oregon, and being all of Lot 4, of Jesse Hobson's Fruit Land Subdivision, and also; commencing at the S.W. corner of Lot 3 of said Jesse Hobson's Fruit Land Subdivision, and running thence North along the West line of said Lot, 10 chains to the N.W. corner of said Lot 3; thence East along the North line of said Lot, 1/2 chain; thence South 10 chains to the South line of said Lot 3, and thence West 1/2 chain to the place of beginning, containing in all $5\frac{1}{2}$ acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
