This Is to Certify, That CHARLES A. EVANS

of Box 768, Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Hayden Slough

atributary of Rickreall Creek

for the purpose of

Irrigation
under Permit No. 15113 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from October 9, 1941

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.78 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the $SV_{\frac{1}{4}}^{\frac{1}{4}}$, Section 2 and $SE_{\frac{1}{4}}^{\frac{1}{4}}$ NE $\frac{1}{4}$ & NE $\frac{1}{4}$ Section 3, Township 8 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shal

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Beginning at an iron pipe on the east bank of Hayden Slough situated in Section 3, Township 8 South, Range 4 West, W. M., in Polk County, Oregon, said beginning point being approximately 24 chains east and 8 chains South of the center of said Section 3 and running thence East 23.95 chains to an iron pipe; thence North 5.32 chains; North 15° 0' East 3.00 chains; North 32° 0' East 9 chains; North 56° 0' East 2.50 chains; North 65° 0' East 4.82 chains; North 70° 0' East 2 chains; North 83° 0' East 9.00 chains; North 5.50 chains; North 45° 0' East 3.83 chains to an iron bar which is the southeast corner of the Muller land; thence West along South line of the Muller land to the east bank of Hayden Slough; thence along the east bank of said Slough with the meander thereof to the place of beginning, containing 62 acres.
