## **CERTIFICATE OF WATER RIGHT**

## This Is to Certify, That JAMES IVAN STEWART

of 833 N. Cottage St., Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

Willamette River a tributary of

for the purpose of

Irrigation

under Permit No. 15211 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 11. 1942

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.0 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the  $NW_4^1$  SE $_4^1$  & SW $_4^1$  SE $_4^1$  & SE $_4^1$  & SE $_4^2$  Section 24, and  $NE_4^1$  Ne $_4^1$ , Section 25, Township 10 South, Range 4 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

38.0 acres in the NE $_{1}^{1}$  SE $_{2}^{1}$ , as projected on D.L.C. 41 6.9 acres in the NW $_{4}^{1}$  SE $_{4}^{1}$ , as projected on D.L.C. 41 35.1 acres in the SE $_{4}^{1}$  SE $_{4}^{2}$ , as projected on D.L.C. 41 Section 24 T. 10 S., R. 4 W., W.M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Those certain premises situated in the County of Linn and State of Oregon, and described as follows, to-wit:

Beginning on the south boundary line of and West 13.90 chains distant from the Southeast corner of the Donation Land Claim of M. D. Byland, Notification No. 1690 and Claim No. 57 in Township No. 10 South of Range 3 West of the Will-amette Meridian, in Linn County, Oregon, and from thence running South 27° 30' East 32.04 chains to the south boundary line of the Donation Land Claim of Hiram Farlow and wife, Notification No. 1672 and Claim No. 56 in said Township and Range; thence South 53° 45' West along said South boundary line of said D.L.C. of Hiram Farlow to the Willamette River; thence with the meandering of said river down stream, North 26° West 8.50 chains, thence North 18° 30' West 5.60 chains, thence North 16° 30' West 14 chains, thence North 2° West 5 chains, thence North 14° 30' West 22.36 chains to the Northwest corner of said D.L.C. of Hiram Farlow and wife, thence East 33.72 chains to the place of beginning, in Linn County, State of Oregon, Except that portion thereof conveyed by Hiram Farlow and wife to Francis M. Allphin by deed recorded November 27th 1856, in Deed Book "A" at

page 196, described as follows: Commencing 2 rods south of the line dividing sections 24 and 25, where said line strikes the Willamette River, starting immediately at the water's edge, running east 8 rods, thence north parallel with the river 20 rods, thence due west to the river, thence south with the river bank to beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
