CERTIFICATE OF WATER RIGHT

This Is to Certify, That ALMA R. PIER

of 2235 N. E. 31st Ave., Portland, State of Oregon, of a right to the use of the waters of the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Unnomed Stream a tributary of Chemelem Creek for the purpose of Conestic under Permit No. 15357 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 25, 1942

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE₄ NW₄, Section 2, Township 3 South, Range 3 West, N.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Being a part of Section 35 in Twp. 2 South of Range 3 West of the Willamette Meridian in Yamhill Co., Oregon & a part of the James R. Bean & wife Donation Land Claim Notification No. 1423, Claims Nos. 39 & 41 in Twps. 2 & 3 South of Range 3 West of the Willamette Meridian in Yamhill Co., Oregon, and particularly described as follows: Beginning at the center of said Section 35 in T. 2 R. 3 West of the Willamette Meridian in said county and state, Running thence South CO⁰ 29' West with County Survey No. 2314, 28.98 chains to the North line of the said James R. Bean and wife D.L.C.; thence North 89° CO! East along said line 1.23 chains thence South O degrees and 17' West 67.88 chains; thence North 89° & 40' West, 12.68 chains; thence North O degrees and 17' East, 24.25 chains; thence North 89° and 40' West 8.26 chains; thence North O degrees and 17' East 72.96 chains; thence South 89° and 13' East 19.80 chains to the place of beginning, containing 179.5 acres, more or less.
